

Holy Trinity Pewley Down - Governing Body Membership 2025/26

The governing body of Holy Trinity Pewley Down has 18 members elected or appointed in different categories:

- 2 Parent governors - elected by parents at the school
- 1 Staff governor - elected by the school staff
- The Head Teacher – appointed by virtue of their office (ex officio)
- 1 Local Authority Governor - nominated by the Local Authority and appointed by the Governing Body
- 3 Co-opted governors - appointed by the Governing Body
- 10 Foundation governors - appointed by Guildford Diocese or the Parochial Church Council (PCC), and including the Rector of Holy Trinity and St Mary's (ex officio)

Governors are appointed for a four-year term. There are four committees: Admissions, Finance & Resources, Children & Learning and Staffing.
